*ADMIN:

An admin fee is applicable to every application. These fees are calculated per hour of administrative time. The figures quoted are therefore a minimum charge and may be multiplied accordingly for particularly time intensive applications.

*LEAD IN:

Please note that longer lead in times will be required for any shoots that involve engagement with residents or suspension of residents' bays

EXTRA INFO:

The fees listed are exclusive of VAT

- You must have Public Liability Insurance with a minimum cover of £5 million in order to gain a license to film and £10 million for filming using a UAS drone
- For all applications, payments must be made immediately, before filming is due to start
- Payment can be made by card online, or via BACS, please send remittance/ proof of payment via email
- Please be aware that some charges may still apply to cancelled applications if processing has already taken place
- Please check with our team for any location specific T&Cs
- To fully apply for suspensions, a parking form and plan must be attached to FilmApp within lead-in time. Once you have submitted your suspension form & plan to FilmApp, these will be sent off for processing and payment must be made.
- Parking cancellation fees: The Bagging Fee + FF Admin Fee is non-refundable once parking is processed, Bay Suspension fees may also be incurred depending on date of cancellation.
