





# Primrose Hill: Filming Guidelines

Primrose Hill has experienced a high volume of location filming/shooting which has made it necessary to establish rules. Primrose Hill residents are keen to ensure that shooting/filming remains within strict guidelines so as not to disturb more than absolutely necessary the peace and harmony of residents and businesses.

#### RESIDENTIAL AREA

Large scale productions (more than 5 crew) will need at least three weeks before the shoot day. Resident meeting may be required for large shoots.

There is no filming permitted on Chalcot Crescent or on the west, north and east sides of Chalcot Square.

### SUSPENSIONS

Resident, Pay & Display/Shared Use parking bays for technical vehicles is restricted to specified bays in the area – please see map over.

Parking on any road outside of this will only be agreed if for essential clearance of shot.

#### **GENERATORS**

Please flag any generator use on the street with the Film Officer. The positioning of the generators has to be approved by the Camden Film Office.

#### **SECURITY**

Camden Film Office may arrange for Camden Council's security to monitor parts or all of any medium to large scale productions. (Usually at a cost of £30ph). The Film Officer will advise further on this.

#### **DEPOSIT**

A deposit may be taken prior to filming – returnable only if the film crew abides by all guidelines.

#### DONATIONS

A donation to the Primrose Hill Community Association is welcomed. Once filming has been conditionally approved by Camden Film Office, productions will be put in touch with the PHCA directly to discuss the donation and this should be given in advance of filming.
